SEC. 14.1 UNIFORM PLUMBING CODE-ADOPTION¹

The Uniform Plumbing Code, prepared by the International Conference of Building Officials, is hereby adopted by reference, subject to any changes set forth in this chapter. The Council, by resolution, may from time to time designate which edition of the Uniform Plumbing Code is currently applicable, since said Uniform Plumbing Code is periodically revised, and the edition so designated by Council resolution shall be the one referred to throughout this Code. Three copies of the Uniform Plumbing Code shall be kept on file in the office of the city clerk. (Ord. No. 312 N.S., '6)

SEC. 14.2 SAME-"ADMINISTRATIVE AUTHORITY" DEFINED

The term "administrative authority" as that term is used throughout the Uniform Plumbing Code adopted by the preceding section, shall mean the building inspector of the City in respect to all matters within any building and within two feet of the outside wall of any building. The term "administrative authority", as it respects any matters beyond two feet outside the walls of any building, shall mean the superintendent of streets of the City. (Ord. No. 203 N.S., '2)

SEC. 14.4 REQUIREMENTS FOR PERMIT TO BUILD; DEPOSIT; REGISTRATION

Every person engaged in the business of installing plumbing in or on buildings or structures in the City shall deposit with the city clerk the sum of fifty dollars as a guarantee that all such installations will be made in the manner specified and provided in this Code.

After the deposit has been made, the person so depositing shall register at the City Hall his name and place of business. (Ord. No. 203 N.S., '7; Ord. No. 348 NS.. '2)
