The project entails modifications at Blair Park, located on Moraga Ave between Red Rock Rd and Maxwelton Rd. The site would be developed with a synthetic turf sports field and a natural turf glade for recreational use. Other primary site modifications would include ancillary structures (e.g., spectator bleachers and concession and restroom facilities), landscaping, four vehicle access driveways, and 40 parking spaces at two parking lots. On Moraga Ave, an at-grade sidewalk, two crosswalks, and roundabout at Maxwelton Rd would be constructed.
